## OBSERVATION :

- #> Single live intra-uterine pregnancy with **variable** position.
- #> Fetal body movements & cardiac activity appears normal.
- #> BPD 48 mm - 20 weeks - 4 days  
HC 180 mm - 20 weeks - 3 days  
AC 149 mm - 20 weeks - 1 days  
FL 31 mm - 19 weeks - 5 days  
**CGA 20 weeks 2 days**
- #> **Placenta anterior , grade I**
- #> **Liquor is adequate for the period of gestational age.**
- #> Heart appears 4 chambered. Both ventricles appears normal, shows usual thickness of the myocardium.. No pericardial effusion.  
Head circumference normal. Ventricular system appears normal in dimension. No hydrocephalus. Choroid plexus are normally placed and show usual echogenicity. Posterior fossa, craniovertebral junction and spine appear normal. No obvious spinabifida.  
Both kidneys are corresponding in length with fetal age. No pelvicaliectasis. Urinary bladder is well distended.  
Stomach bubble is in its usual position. Bowel loops show usual echogenicity. Fetal limbs appear normal.
- #> **Internal os closed. Cervix appears normal.(4.1 cm)**
- #> **Fetal heart rate - 147 BPM.** #> **Fetal weight is 323 gm**
- #> **EDD by CGA : 29/10/2023**
- #> **right uterine artery PI- 0.9 , Left uterine artery PI- 0.9 , normal.**

## IMPRESSION :

**A single live intrauterine fetus of sonic gestational age of 20 weeks 2 days.**

**No obvious congenital anomaly for the gestational age.**

**Follow up suggested for evolving.**
