- Uterus is gravid reveals a single live intrauterine gestation.
- Lie and Presentation : Variable
- The fetal cardiac activity & fetal movements are well visualised during scanning. present
- The FHR is 168 beats per minute.
- CRL = 55.0 mm em: 12 weeks 1 days
- The calculated average gestational age of the fetus is 12 wks 1 days.
- The placenta is developing.
- Liquor adequate / inadequate for GA.
- The internal os is closed & cervix measures 3.1 cm.
