USG OBSTETRICS (NT & NB SCAN)

LMP: - 14.07.2023

Gestational age (According to LMP) :- 12 wks 02 days

E.D.D. (According to LMP) :- 19.04.2024

OBSERVATION

- Single, live intrauterine gestational sac, foetal pole seen.
- Foetal movement and cardiac activity are present. FHR is regular, 168 bpm.
- CRL 53 mm corresponding to 12 weeks 0 day.
- Mean gestational age by USG = 12 weeks 0 day (\pm 1 wks).
- EDD by USG = 21.04.2024 (\pm 1 wks).
- Cervical length is normal. Internal OS is closed.
- No free fluid seen in pelvis.
- Forming placenta noted in Posteriorly with grade 0.

IMPRESSION:

- Single live intra-uterine gestation of mean gestational age of 12 weeks 0 day.
- EDD by LMP=19.04.2024
- EDD by USG=21.04.2024
- Nuchal translucency thickness= 0.6 mm (Normal)
- Nasal bone present

ADVICE

USG malformation scan (with 3D/ 4D sonography) to rule out congenital anomaly / malformation/ any limb deformity at 18-20 wks.
