C.E.C.T. UROGRAPHY

Multiple computed 2mm and 5mm sections using 32 detector rows of urography were obtained before and after administration of 85ml C.T.VIEW 300 I.V. non-ionic contrast.

Grade I PU junction obstruction left kidney with radio-opaque calculus in the left renal pelvis. Size of calculus 6 x 7 x 12 mm AP, TR & CC (HU178). Mild hydronephrosis is seen in left kidney. No elevation of bilateral perinephric fat plane. Small cyst is seen in lower pole of left kidney of size 2.2 x 1.8 cm.

Right kidney measures 8.9 x 2.0 cm and left kidney measures 8.3 x 2.5 cm. Both kidneys show normal nephrogram in arterial phase, good excretion of contrast in portal phase and normal pelvicalyces in delayed phase. No evidence of radio-opaque calculi or hydronephrosis on right side.

Both ureters show normal calibre and course.

The urinary bladder, prostate and seminal vesicles are normal.

No evidence of abdominal or pelvic lymphadenopathy.

Liver, gall bladder, intrahepatic biliary radicals, pancreas, spleen and adrenals are within normal limits.

Sections through the chest reveals no focal lesion.

No lytic or sclerotic lesion in the visible bones.

Impression:

- Grade I PU junction obstruction left kidney with radio-opaque calculus in left renal pelvis as described.
- Small benign cyst in lower pole of left kidney.
- No other significant demonstrable abnormality detected in C.T. Urography.

Lab and clinical correlation is suggested.
