OBSTETRIC SONOGRAPHY REPORT (1st TRIMESTER)

The uterus is antverted, bulky in size (physiological) & shows normal shape & Echotexture.
There is single well defined gestational sac seen in the uterus.

Single embryo with secondary yolk sac seen.

Cardiac activity seen. FHR : 150 b/min

The CRL = 13.4 mm = 7 wks 4 days.

The usg guided E.D.D. is 09/08/2024 (+/- 1 wks).

Cervix appears normal, Cervical length is 3.6 cm. Internal os is closed.

Right ovary is normal in size, shape & echotexture. It measures 3.3 x 2.2 cm.

Left ovary is normal in size, shape & echotexture. It measures 2.6 x 1.9 cm.

- No mass lesion seen in either adnexa.
- No free fluid noted in the pelvic cavity.

IMPRESSION:- EARLY SINGLE LIVE, INTRAUTERINE PREGNANCY SEEN WITH SON
MATURITY OF 7 WKS 4 DAYS AT THE TIME OF EXAMINATION.

Suggested follow up at 12-14 wks for NT evaluation of fetus.
