Ultrasonography of gravid uterus (Early anomaly/NT scan)

- ❖ Single live intrauterine fetus with changing lie & unstable presentation is seen at the time of examination.
- ❖ CRL measures 4.94 cm corresponds to 11 weeks 5 days.
- ❖ Foetal cardiac activity is noted. Foetal heart rate 178 b/min.
- ❖ Nuchal translucency- 1.4 mm.
- ❖ Intra-cranial translucency- 1.7 mm.
- ❖ Nasal bone (2.3 mm), Tricuspid flow: within normal limits.
- ❖ Ductus venosus flow is normal.
- ❖ Placenta: Posterior wall, upper and mid uterine segment. Grade-0 maturity.
- ❖ OS closed.
- ❖ Both ovaries appear normal in size and echotexture.
- ❖ Cervical length 3.8 cm.
- ❖ Urinary bladder shows normal uniform wall thickness with smooth inner margin.

IMPRESSION:

- ❖ Single intrauterine gestational sac with single live fetus with heart activity seen at the time of examination with gestational age of 11 weeks 5 days.
- ❖ Expected date of delivery by ultrasound: 14.08.2024 +/- 10 days.
- ❖ Uterine artery screen negative for PIH.
- ❖ Measured nuchal translucency (1.4 mm) is 60th percentile for present CRL.

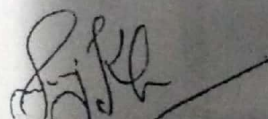
Suggest:- Follow up TIFFA (level II) scan between 19-21 weeks.
