OBSTETRIC SONOGRAPHY

in real time. B mode, gray scale sonography of gravid uterus was performed.

- » LMP : 17.12.2023
- » GA (By LMP) : 13 wks 1 days. GA (By USG) : 13 wks 3 days (+/-15 days)
- » E.D.D. (By LMP) : 22.09.2024 EDD (By USG) : 20.09.2024
- » A single gestational sac is noted in uterine cavity.
- » A single live fetus with following parameters is seen.
- » CRL: 7.2 cm corresponding to gestational age of : **13 WKS 2 D**
- » Nuchal translucency : 1.4 mm.
- » Nasal bone seen.
- » Cardio -somatic activity is normal (FHR: 159 bpm)
- » Placenta: Fundus , Grade: 0.
- » The internal os is closed.
- » No intra-/retroplacental bleed seen.
- » Cervical length : 4.0 cm.




Single, live, intrauterine fetus with gestational age of 13 wks 2 d .
