OBSTETRIC ULTRASOUND (ANOMALY SCAN)

Real time USG of pelvis was performed with multifrequency 2.0 to 5.0 MHz convex transducer with tissue harmonics of GE LOGIQ P9.

LMP : 20/04/2024

GA : 20 wks 06 days,

EDD BY LMP :25/01/2025

There is a single live intrauterine fetus with changing presentation.

Fetal cardiac activity (FHR- 150 bpm) and movements appear normal.

Liquor is adequate

Placenta is ANTERIOR and shows Grade I maturity, safely away from the internal OS . Internal OS is closed at present.

Cervical length : 3.0 cm.

Anomaly scan :

CARDIAC

Heart is seen in the left side of thorax with its 4 chambers.

Its apex is pointing towards left.

Cardio-thoracic ratio is normal.

All 4 chambers are of equal dimension approximately.

Atrio-ventricle & ventricle-arterial concordance is maintained.

4 chamber view, LVOT, RVOT images are normal.

CNS

Septum pellucidum & cerebellum are normal.

Mid line appears normal.

No obvious dilatation of ventricle system noted in present examination.

Spine is normal with no obvious evidence of open neural tube defect.

Left Ventricle 5.3 mm. cisterna magna 5.1mm. Cerebellum measures 19.6 mm.

E/o bilateral tiny anechoic choroid plexus cyst of size 0.2 x 0.2 cm on right and 0.3 x 0.4 cm on left side.

FACE

No obvious evidence of cleft lip & palate noted.

Both orbit are symmetrical & of normal dimensions with normal appearing eye globe within it.

ABDOMEN

Normal stomach bubble is seen on left side.
No ascites or bowel dilatation or echogenic bowel noted.
Anterior abdominal wall is intact and normal.

GUT

Both kidneys are normal in echogenicity.
No hydronephrosis noted. Bladder was seen.

THORAX

No abnormal cystic or solid structure is noted in both hemithorax.
No evidence of pleural effusion noted in present examination.

LIMBS

Long bones of all the 4 limbs are well seen with normal bone length & orientation.
No obvious abnormality detected.

CORD

3-vessel cord is seen.
Its normal insertion is seen on anterior abdominal wall with no evidence of omphalocele.


