### SURGICAL PATHOLOGY REPORT

- SPECIMEN** : Resection of small bowel segment
- CLINICAL HISTORY** : Subacute intestinal obstruction.
- GROSS** : Received a segment of intestine measuring 50 cm in length. Lumen appear constricted at places. Mesentery shows areas of congestion. Mucosal surface shows loss of folds and thickening. Separately seen segment of intestine measuring 7 cm in length. Cut section is unremarkable. Separate fibrofatty tissue measuring 5 x 3 cm.
- MICROSCOPY** : Sections from the constricted area show atrophic mucosal lining with lamina propria showing increased fibrous tissue, fibroblasts and lymphoplasmacytic infiltration. Areas of mucosal erosions with neutrophilic and eosinophilic infiltration noted. A few epithelioid histiocytes seen in the lamina propria. Inflammatory infiltrate seen extending into the submucosa and muscularis propria. Separate segment of bowel shows moderate chronic inflammation. Fibrofatty tissues show dilated congested vascular channels and extravasated RBCs.
- IMPRESSION** : **Resection of small bowel segment:**  
**Intestinal mucosal tissues with severe chronic active inflammation, epithelioid histiocytes and lamina propria fibrosis.**  
**Negative for dysplasia/micro-organisms / malignancy.**
- ADVISED** : Possibility of inflammatory bowel disease/immune related etiologies to be considered. Recommended additional evaluation
