

The uterus is anteverted, bulky in size (physiological) & shows normal shape & echotexture.

Both the ovaries are normal in size shape and position.

Bilateral adenexa appears normal.

No evidence of any lesion noted in the uterus.

The internal os is closed at time of scan.

Cervical length is 4.2 cm.

Cervix appears normal.

No e/o sub chorionic bleed noted.

Thin strip of free fluid in POD.
