* Ductus venosus Doppler: Triphasic wave pattern

* Nuchal Translucency measures: 1.6 mm

* Placenta developing posterior wall

* Cervical length measures 3.1 cm

* Visualised limbs, spine and fetal skull appears normal

* Internal os is closed



Suggest anomaly scan at 18-22 weeks. (27 April 2025)







Cervical canal is normal. Cervical length is 2.9 cm



Internal os is closed.




