Fetal structures are not sufficiently developed in first trimester to allow accurate assessment. Still, in good faith, we make the best possible efforts to detect all anomalies possible to be detected on sonography at this time. This is early screening test to rule out obvious major defects and should not substitute detailed anomaly scan at second trimester. The optimal visualization of fetal parts can be affected by fetal position, fetal movements, maternal obesity and adequacy of liquor.

This Report is not for medicolegal purpose. Investigation can be affected by technical and physical factors.  
Solitary radiological investigation never confirms the final diagnosis and must be correlated with clinical findings and other investigations.

### OBSTETRIC SONOGRAPHY

The real time, B mode, gray scale sonography of gravid uterus was performed .

L.M.P. : 07.12.2024

Gestational age by LMP : 14 WKS 3 D

E.D.D. by LMP : 13.09.2025

#### *Routine grey scale assessment:*

- The uterus is gravid.
- A single live fetus with following parameters is seen:

#### **FOETAL PARAMETERS:**

PARAMETERS	MEASUREMENT (cm)	GESTATIONAL AGE
Biparietal Diameter (B.P.D.)	2.6	14Week 4Days
Head Circumference (H.C.)	9.9	14Week 5Days
Abdominal Circumference (A.C.)	8.4	14Week 6Days
Femur Length (F.L.)	1.2	13Week 6Days

- Gestational age by USG: 14 weeks 4 days
- E.D.D. by sonography : 12.09.2025
- Cardio-somatic activity is normal, FHR 158 BPM.
- Placenta is posterior, lower margin 3 cm away from os
- There is no evidence of subchorionic haemorrhage at the time of examination.
- The internal os is closed, Cervical length : 3.3 cm

#### *Fetal anatomical assessment:*

- Normal midline falx and choroid plexus filled ventricles seen.
- No abnormal intraabdominal lesion noted.
- Fetal heart shows two inflow tracts
- Four limbs, each with three segments imaged.
- Single umbilical artery is noted. Left umbilical artery is present. Right umbilical artery is absent.

#### *First trimester aneuploidy markers:*

- Nuchal translucency not measured due to advanced gestational age, however nuchal fold thickness is upto 2mm
- Nasal bone appears normal.
- Ductus venosus reveals normal triphasic forward flow without reversal.
- No tricuspid regurgitation is noted.

#### *Doppler for Preeclampsia screening:*

- Average Uterine artery PI: 2.25 (96<sup>th</sup> percentile- pathological)

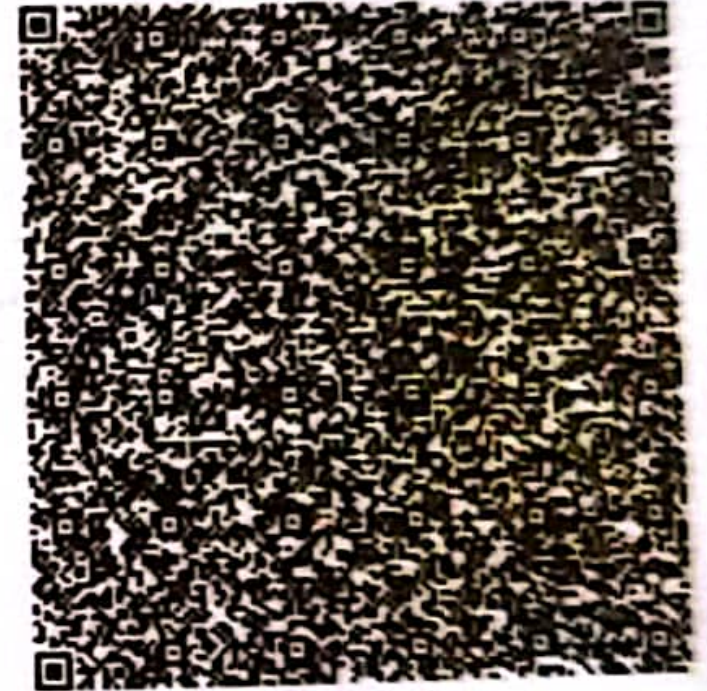
