OBSERVATION

- Bulky gravid uterus with well defined normal thickness gestational sac of MSD – 11.6 mm corresponding to 5 week 0 day.
- No evidence of subchorionic hematoma.
- Single yolk sac is seen.
- No evidence of fetal pole or cardiac activity at present.
- Internal os closed.
- No adnexal pathology is seen.
- No suggestion of Ectopic pregnancy.
