USG Neck

E/o large 4.7x3.8cm size well-defined heterogeneous vascular lesion seen in sub-mental region which is separately seen from sub-mandibular gland and thyroid gland .

Right lobe Thyroid - 9.4x10.6mm

Left Lobe Thyroid- 8.9x7.4mm

Isthmus -3.1 mm.

Both lobes of thyroid normal in size and echotexture.

Both neck vessels shows normal flow .


Bilateral parotid and sub-mandibular glands appears normal in size and echotexture.

IMPRESSION:

- Large 4.7x3.8cm size well-defined heterogeneous vascular lesion seen in sub-mental region which is separately seen from sub-mandibular gland and thyroid gland likely neoplastic in etiology.

Cytopathology Report

SPECIMEN :

FNAC of left submandibular swelling.

CLINICAL HISTORY :

Left submandibular swelling under evaluation.

GRCS :

Scanty haemorrhagic aspirate obtained.

MICROSCOPIC :

- Smear revealed moderate cellularity.
- It shows singly scattered and in clusters Spindle cells.
- Cell shows mild to moderate nuclear pleomorphism.
- Occasional round cells with scanty cytoplasm detected.
- Fragments of myxoid stroma detected.
- There is no evidence of frank Malignancy in the present smear.

IMPRESSION : -

Left submandibular swelling : Cytology suggestive of Pleomorphic adenoma

NOTE :

Further evaluation and confirmation with Excision and histopathology is suggested.
