- Single, intrauterine pregnancy seen with **changing** presentation at the time of scan.
- Foetal movement and cardiac activity are present. FHR is regular, 155 B/MIN.

Biometry:

BPD	2.05 cm	corresponding to	13w2d	
HC	7.65 cm	corresponding to	13w2d	
AC	5.99 cm	corresponding to	12w5d

Mean gestational age by USG = 13w0d (± 1 wks).

- EFW = 63 g ± 10 gms.
- Cervical length is normal (3.5 cm). Internal OS is closed.
- Placenta - Left antero-lateral, Grade 0 maturity.
- Liquor - Appears adequate for the age. (Subjective assessment)
- All four limbs are visualized.
- Bilateral uterine artery PI is within normal limit.
- Ductus venosus flow appears to be normal.

EDD by USG = 26 Mar 2026

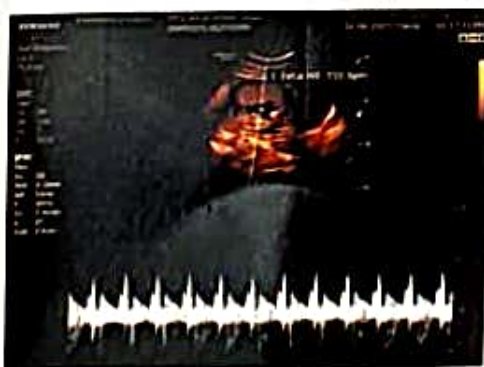
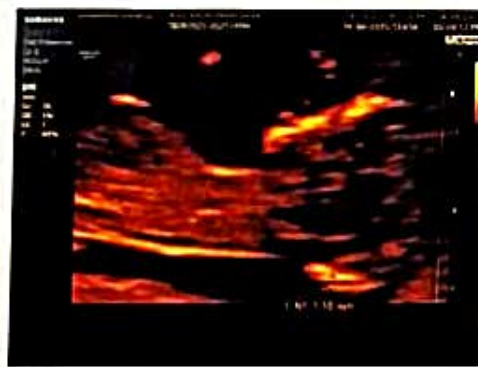
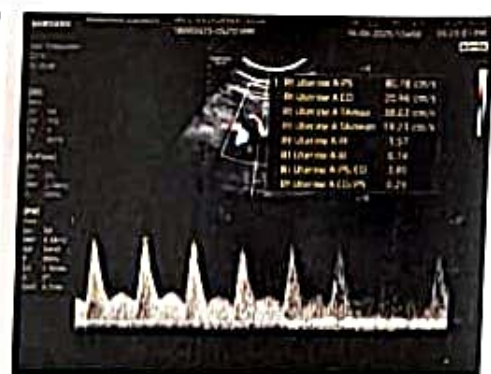
- Single live intra-uterine gestation of mean gestational age of 13w0d (± 1 wks) in **changing** presentation at the time of scan with EDD of 26 Mar 2026.
- Nuchal translucency thickness = 1.1 mm (normal).
- Nasal bone present (2.3 mm - normal).

Advice - USG malformation scan to rule out congenital anomaly / malformation at 18-24 wks.
