

There is a single gestation sac in uterus with a single fetus within it in cephalic position.

The fetal cardiac activities and body movements are well seen.

Placenta is posterior in position and grade I in maturity.

Amniotic Fluid: Normal

Internal OS is closed and length of cervix is normal (4.2 cm)

No congenital anomaly is detected at this stage. (Please see foot note.)



SPINE

Entire spine visualized in longitudinal and transverse axis.
 Vertebrae and spinal canal appear normal.
 No evidence of neural tube defect is noted.

NECK

No cystic lesion seen around the neck.
 The Nuchal fold thickness measures 3.8 mm. ✓

FACE


Fetal face seen in the coronal and profile view.
 Both Orbita, nose and mouth appeared normal.

THORAX

Heart appears in the mid position.
 Normal cardiac situs. Outflow tracks appears normal.
 Both lung seen.
 No evidence of pleural or pericardial effusion.
 No evidence of SOL in the thorax.
 Detailed Fetal Echocardiograph may be suggested at appropriate time if indicated.

ABDOMEN

Abdominal situs appeared normal.

Stomach bubble seen.

Normal bowel pattern appropriate for the gestation seen.

No evidence of ascites.

Abdominal wall intact.

Fetal both kidneys appeared normal.

Fetal urinary bladder appeared normal

LIMBS

All fetal long bones visualized and appear normal for the period of gestation.

Both hands and feet appeared grossly normal.


IMPRESSION :

- Single live intrauterine gestation in cephalic presentation at the time of examination with gestational age as per LMP with sonographic maturity of 21 weeks 3 days S/o normal fetal growth as per gestation.
- Assigned EDD as per LMP is 28/04/2026.
- No obvious sonographically detectable structural anomaly seen at present scan.
- Normal and adequate quantity of liquor.
- The scan does not contain fetal ECHO. (Adv- Fetal Echo for detail cardiac evaluation)
- Evaluation of maternal uterine Doppler shows normal proper placentation (mean PI- 0.8).
- Patient-specific risk for Down syndrome posterior probability 1 in 543.
- Adjusted risk is 1 in 4172.

Suggested Growth scan at 28 weeks: 03/02/2026 ± 7 days

Suggested Doppler scan at 34 weeks: 17/03/2026 ± 7 days

Please note that all anomalies can not be detected all the times due to various technical and circumstantial reasons like gestation period, fetal position, quantity of liquor etc. The present study can not completely confirm presence or absence of any or all the congenital anomalies in the fetus which may be detected on post natal period. Growth parameters mentioned herein are based on International Data and may vary from Indian standards. Date of delivery (at 40 weeks) is calculated as per the present sonographic growth of fetus and may not correspond with period of gestation by L.M.P. or by actual date of delivery. As with any other diagnostic modality, the present study should be correlated with clinical features for proper management. Except in cases of Fetal Demise or Missed Abortion, sonography at 20-22 weeks should always be advised for better fetal evaluation and also for base line study for future reference.


