**ULTRASOUND OF GRAVID UTERUS  
LEVEL II CONGENITAL ANOMELY SCAN**

**LMP: 07/09/2025 GA by LMP: 20 weeks and 1 days. (EDD by LMP -14/06/2026)**

There is a single live intrauterine gestation noted in changing lie, exhibiting normal cardiac activity and movements. FHR: 150 bpm.

**FOETAL BIOMETRY:**

BPD : 4.6 cms - 20 weeks and 1 days.

HC : 17.5 cms - 20 weeks and 0 days.

AC : 14.4 cms - 19 weeks and 4 days.

FL : 3.4 cms - 20 weeks and 4 days.

Estimated foetal weight 335+/- 30 gms.

Average gestational age by ultrasound 20 weeks and 0 days(EDD by USG -15/06/2026)

**Fetal head:** - Normal intracranial structures. Falx is in the midline, normal ventricles, normal cisterna magna. No choroid plexus cyst is seen.

**Fetal spine:** - Normal curvature. No open defect.

**Abdomen:**-Fundic bubble is in normal in size and position. Normal fetal kidneys. Ureters are not dilated. Normal fetal bladder. No bowel obstruction.

**Heart:** - Normal cardiac axis. Cardiac chambers are normal. No chamber wall hypertrophy. Normal arch. **Chest:**-No evidence of any pleural effusion or any intrathoracic mass.

**Face:**-Visualized normal fetal face. Pre-maxillary triangle is normal. No cleft lip. Normal orbits.

**Limbs:**- All four limbs were visualized. No skeletal anomaly.

The placenta is anterior in location. Liquor is adequate.

The internal os is closed. The cervical length measures 3.5 cms.

**IMPRESSION :**Single live intrauterine gestation in changing lie at present scan of average gestational age 20 weeks and 0 days.

**Suggest :**Triple marker/ Quadruple marker correlation /Fetal 2-Decho at 24 weeks by echocardiography specialist.

\* Disclaimer note:- All congenital anomalies cannot be detected by USG . This is not a fetal echocardiography. It is advisable to perform a fetal echo to rule out cardiac anomalies. All measurements including birth weight are subject to statistical variations.\*
